Attached is the amended complaint by the Johnson County Prosecutor's Office which is scheduled for trial on June 13, 2005 as a result of your falsely reporting that I violated K.S.A. 21-4707 after you were informed in writing by U.S. Postal Inspector Tom Rebotarro that the U.S. Attorney's Office had determined that the March 17, 2003 letter and settlement offer is a constitutionally protected activity.
